## 1 Introduction

The objective of this deliverable (D4.2) is to present the features of the IDIH website and how it will be managed during the project lifetime.

The IDIH website is available since July 23<sup>rd</sup>, 2019 (Month 3). It was set up in responsive design in order to be correctly displayed on any type of device (ranging from regular PC to mobile devices).

The website shall represent a key communication channel in raising awareness of the project and serve as main repository for public project documents and outcomes all during the project lifetime. It contains a general presentation of the project and its objectives, an overview of the IDIH consortium, as well as an outline about activities and project features to come.

It shall target all audiences of the project such as Policy Makers; RDI/RTI stakeholders and industry representatives; Networks, clusters and other innovation 'facilitators/multipliers'; relevant projects/initiatives; and society/user groups (notably elderly population).

The website visitors will find information about project advancements, outcomes and potential impacts. They will also have access to publications, public deliverables and other outcomes, and information on activities planned by the project (e.g. webinars, events).

The website has been developed and will be maintained by project partner inno TSD with the contribution from all the IDIH partners, and aims to fulfil the following specific objectives:

- Act as contact point for stakeholders
- Provide a brief project presentation and project information
- Provide information about the IDIH consortium and the role of the partners, and a link to the partner organisation's websites
- Inform stakeholders about the results or activities of IDIH and opportunities and events around IDIH
- Act as an online knowledge repository (public deliverables, publications, flyers, etc.)
- Follow the IDIH branding and play an important role in the information campaign

The content of the IDIH website will be updated continuously, i.e. whenever relevant, especially with respect to information on project publications and events.

## 1.4.1 Homepage

The homepage is the landing page where the visitor can discover the IDIH project, its identity and what the project intends to do with a clear and easy-to-find value proposition. The homepage consists of a slider show in the upper part of the website and allows the user to scroll down to access the main information of the page.

The slider show currently consists of two sliders, one containing a representation of the IDIH main topics, the other establishing the link from the 'Digital Health Transformation Forum' to the 'Expert Groups' section.

Overall, the homepage is split into different parts as explained below.

## 1.4.1.1 IDIH key words, slogan and project title

Key words highlighting the main topics of the IDIH project ("International Collaboration, Digital Transformation, Healthy Ageing"), had been integrated in the project logo already. In addition, a short slogan ("International Collaboration and Digital Transformation") is used on the first of the sliders in the upper part of the page.

A specific news section is available on the landing page. In this section, the three most recent news can be checked. Currently, two first news about the project start as well as the Kick-off Meeting have been published.




Figure 4: IDIH Homepage – news part

Landing page for this section is the 'IDIH Project' subsection.








#### 1.4.2.1 IDIH Project

This section provides informing on key data, background, objectives of the project and the approach.






Figure 7: "IDIH Project" page - presentation of IDIH in a 'snackable' manner



## **Digital Health Transformation Forum**

Collaboration relies on the involvement of stakeholders concerned by the area. For this reason, IDIH will set-up an expert-driven "Digital Health Transformation Forum", consisting of four IDIH Expert Groups.

These Expert Groups will undertake collaborative actions in the selected four strategic topics (Preventive care; Integrated care; Independent and connected living; Inclusive living). This open and collaborative approach will ensure the involvement of RDI and policy stakeholders, as well as user associations where relevant. The "Digital Health Transformation Forum" is expected to become a long-lasting mechanism for an international dialogue in digital health.

IDIH will set up and operate a **Digital Health Transformation Forum**, **consisting of four IDIH Expert Groups**. Each Expert Group shall focus on a specific topic, and exchange in areas and topics of collaboration in digital health domains, thus ensuring mutual learning and knowledge exchange between countries and regions addressed by the project.

This way, synergies and promising avenues, as well as open issues for all countries and regions addressed by IDIH shall be discussed and exploited and concrete measures for collaboration and next steps needed for enhancing successful collaboration in priority areas through the development of a Roadmap shall be proposed.

Direct access to each of the subsections is provided on top of the page for easy access at any time.





Figure 12: "Outcomes" Section




Figure 15: "Contact" Section
